## Entry Requirements

### English Language

- Evidence that you have been instructed and assessed predominantly in English for a significant part of your educational career, or
- IELTS Score of 6.5 overall with no less than 6.5 in any subcomponent
- Evidence of an equivalent result in an appropriate English language examination

### Educational Background

You should be 18 years or over at the start of the programme and hold an equivalent to:

- Minimum 2:2 in legal degree discipline, or
- An acceptable professional qualification equivalent
- At least two years' work experience in a legal environment

Following the review of application, students may be required to:

- Attend a face-to-face interview, or
- Take part in a telephone interview
