About

If you're looking for a flexible professional qualification in governance, then ICSA's Advanced Certificate in Corporate Governance is for you.

It's suitable for anyone who undertakes governance activities - whether you're a lawyer or accountant who deals with governance as part of your job; an existing chartered professional who wants to update your corporate governance knowledge; or you work in the company secretarial arena and are looking for a comprehensive stand-alone qualification in governance.

ICSA's Advanced Certificate in Corporate Governance will equip you with the knowledge and practical skills required to act as adviser to governing authorities across the private, public (excluding NHS - see ICSA's Advanced Certificate in Health Service Governance qualification) and voluntary sectors.

The Advanced Certificate in Corporate Governance is set at level six (final year undergraduate level) and completion of course results in the awarding of a certificate.

Those who complete the certificate qualification can go on to study for CSQS, and are exempt from the Corporate Governance module.

Entry

This certificate is designed for anyone who wants a graduate-level qualification in corporate governance. People in the following roles may find this qualification beneficial:

- Members of company secretarial or governance teams
- Compliance officers
- Risk managers
- Those in legal or accountancy roles who undertake governance duties.

The Advanced Certificate in Corporate Governance is an open-entry qualification, although ICSA recommend that students are working in a relevant role and/or have some work experience in the area.

Content

This course covers:

- General principles of corporate governance
- Legal and regulatory aspects of corporate governance
- Codes of and reports on corporate governance
- Application of governance rules and principles
- Role of the company secretary
- The board of directors/board of governors
- Remuneration of directors and senior executives
- Reporting to shareholders and external audit
- Relations with shareholders
- Risk management and internal control
- Corporate social responsibility and sustainability.

Assessment of the course is via a three hour exam, taken in June or November Study. Recommended study time for the whole course is 150 hours.
